




HEMBLEN continued to reside in Miami, Florida.

## II. MIAMI CONVENTIONS COALITION (MCC)

The MCC was formed at a national meeting in Washington, D. C. on May 20, 1972, as a coalition of groups planning protest activities at the Democratic and Republican National Conventions. The MCC is head-quartered at 1718 Alton Road, Mismi Beach, Florida.

The PCPJ is a coalition of over 100 organizations which uses massive civil disobedience to combat racism, poverty, repression and war.

On July 1, 1972, a meeting of the MCC was held at MCC Headquarters in Miami Beach. The subject attended this meeting wherein the organizations of MCC was discussed. After a considerable time, it was agreed that an eight member Steering Committee would be elected. HEMBLEN was nominated to the Steering Committee.
